No entries will be accepted after 5:00 PM CET on 13 October 2021.

This registration form should NOT be returned to Cambridge Assessment Admissions Testing but should be handed to your test centre. All entries must be made by registered centres via the Cambridge Assessment Admissions Testing Entries Extranet.

BMAT - Please note, applicants must only take BMAT once in an admissions cycle.
